All repair or remodeling jobs, changing or replacements of each individual plumbing fixtures:	\$7.50/each
Installation of roof drains and roof overflow drains when piping to such drains are run inside of buildings and wasted into a storm drain system including natural storm drain run-off areas:	\$7.50/each

In commercial, industrial, multi-family residential, one and two family dwellings and institutional structures, the permit fee shall be based on the valuation of the entire plumbing installation, which is to be declared on the permit applications.

**COMPUTATION OF FIXED-FEE PERMIT SURCHARGES**

Where the fee for the permit issued is a fixed amount the surcharge is equivalent to ½ mill. (.0005) of the fee or \$5.00, whichever is greater.

**COMPUTATION OF VALUATION-BASED PERMIT SURCHARGES**

Where the fee for the permit is based upon valuation the surcharge is as follows:
